Since knowledge was recognized as a crucial part of intelligent systems in the 1970s and early 1980s, the problem of the systematic and efficient acquisition of knowledge was an important research problem. In the early days of expert systems, the focus of knowledge acquisition was to design a suitable knowledge base for the problem - main by eliciting the knowledge from available experts before the system was completed and deployed. Over the years, alternative approaches were developed, such as incremental approaches which would build a provisional knowledge base initially and would improve the knowledge base while the system was used in practice. Other approaches sought to build knowledge bases fully automatically by employing machine-learning methods. In recent years, a significant interest developed regarding the problem of constructing ontologies.
