Applying for State License | FSBPT

The thirty (30) hours of continuing competence requirements per biennium shall include a minimum of four (4) contact hours specifically in ethics and jurisprudence as defined in the Georgia Physical Therapy Act or by passage of the Georgia Jurisprudence Examination. Passage of the examination is equivalent to the four (4) hour requirement.

Georgia Physical Therapy CE - Approved Online Continuing ...

Some licensees will need to complete the jurisprudence examination as part of the renewal process, and will be prompted to do so. Unless prompted, applicants are not required to complete the jurisprudence examination. Some licensees will be prompted to provide evidence of the completion of 40 hours of Category 1 CME.
