These exemptions can be found in CA Fin. Code Section 22100(b) for the California Finance Law (CFL) and Section 50002.5(a) for the California Residential ...

The submission of Mortgage Call Reports (MCRs) is a SAFE Act requirement for all Company filings and is also required pursuant to California Business & Professions Code section 10166.08. Failure to submit required MCRs to NMLS will delay and may prevent the approval of the renewal request.

Mortgage Loan Origination (MLO) - NMLS/SAFE ACT - DRE

The Act requires all MLOs seeking state- licensure to pass the NMLS-developed SAFE Mortgage Loan Originator Test with a score of 75% or better.
