### Annual Leave Accrual, Carry Over, and Cashing in

Generating a Letter of Request to Carryover Unobligated Funds: The request must include the grant number and PI name. The request must include an appropriate scientific justification: A plan for the use of funds, A detailed categorical breakdown, including F&A costs, if applicable, A justification of the unobligated balance of funds. The scope of the request should be limited to the approved goals of the project, or clearly delineate where the request exceeds the approved goals of the project.
